- 2) Be delivered by a multi-state or multi-national postage or carrier service, including but not limited to USPS, FedEx, UPS & DHL. If above conditions are not met, the entries are not valid and must be returned to the sender.
- 3) Express mail must be designated "no signature required".

A 100% refund of the entry fee will be given for any bitch that comes into season with written notification from a veterinarian provided to the Trial Secretary.

Walk-through & Warm-up

Handlers in all classes will be permitted to walk the course without a dog prior to the start of the class. At the discretion of the judge, if the size of the entry for any class might inhibit a safe and fair walk-through by handlers, height divisions may be used to divide the walk-through into groups, e.g. walk-through for the 8", 12" and 16" division handlers followed by runs for those height divisions; then walk-through and subsequent runs for the 20", 24" divisions. A warm-up area, consisting of a regulation agility jump, will be provided. Umbrellas are not allowed on the course during the walk through.

CLASSES OFFERED & JUDGING TIMES

Classes Offered

ISC STD and ISC JWW will be offered according to the entry form. (International Sweepstakes Classes will be offered when indicated in the premium and on the entry form). A complete set of rules for all classes is available from the American Kennel Club, 8051 Arco Corporate Drive, Suite 100, Raleigh, NC 27617-3390, or from the AKC web site. It is the exhibitor's responsibility to enter their dog in the correct class. The Trial Secretary cannot make any changes (except for move-ups as noted) after the closing date of the trial. Be sure to check your entry form carefully and make certain you have entered the correct class(es).

OBSTACLES AND EQUIPMENT

<u>Obstacles</u>

Obstacles shall meet the specifications for obstacles in the current edition of AKC Regulations for Agility Trials. There will be no equipment familiarization at this trial. As of 9/1/06 AKC does not allow it. An FCI style soft broad jump, and 4' bars will be used.

<u>Equipment</u>

The equipment for this event is provided by Elissa Looney of Corral Creek Dog Sport Center.

CRATING INFORMATION

THERE IS CRATING SPACE AVAILABLE IN THE BUILDING. However, It's suggested that crating be primarily out of cars. Dogs MUST be quiet while crated out of consideration of our neighbors.

WORLD TEAM TRYOUT QUALIFICATIONS

This event is a World Team Bye Event. The bye will be earned from a combined score taken from the following classes:

- Saturday ISC STD 2 Designed by Kine Eimhjellen
- <u>Sunday ISC JWW 2 Designed by Neil Ellis</u>

AKC World Team Tryouts (WTT) 2025 Qualifying Event: This event will be a WTT Qualifier Event. The combined scores from ISC Standard 2 on Saturday, June 29, and ISC JWW 2 on Sunday, June 30, 2024 will be used to award the WTT Combined ISC Class Award. To be eligible for the WTT Combined ISC Class Award, the team must have a clean Std or JWW run and a run that has a maximum of 5 course faults (no time faults allowed) for those scores to be used to compute the Combined Score. The Combined Class winner from the 12, 16, 20 and 24 inch height is invited to attend World Team Tryouts 2025. They do not need to fulfill the requirement of the 4 Std/4 JWW scores. The team must also send in all the required information for entering the WTT with the fees and the entry form and meet all the other basic eligibility for WTT (including an approved pedigree). The handler at tryouts must be the same handler that won the combined award.

WTT Bye overall placements and ribbons will be provided for 1st through 3rd, though only the first place team that also meets the above requirements will receive the bye to Tryouts.

SPECIAL CUP PRIZES

In addition to the World Team Bye, we will have special prizes during the trial. These will be awarded on Sunday :

- My First ISC Q ribbons
- High-in-trial Level 1
- NQ Raffle
- High-in-trial Levels 2 & 3 (combined)

See details as follows:

High-in-trial: Level I

This prize is open to dogs that are only entered in Level I courses. You must enter in and compete in at least 4 of the 6 Level I courses offered over the three days. Your dog may not be entered in any higher levels to be eligible.

Two tiers will be offered; one tier each for dogs in 16" or lower height classes and one for dogs in 20" and higher height classes. 16" Select dogs will be scored with the 20" dogs. Ribbons will be awarded from 1st to 3rd place in each height group.

> Points will be accumulated based on the following system: Clean Run = 10 points Single Fault Runs = 7 points Two Fault Runs = 5 points Non-E Runs = 3 points

Fastest time in class without an E = Bonus 5 points

High-in-trial: Levels 2/3

This prize is open to dogs that entered any combination of Level 2 or Level 3 courses. You must enter in and compete in at least 6 Level 2 or Level 3 runs over the three days.

Two tiers will be offered; one tier each for dogs in 16" or lower height classes and one for dogs in 20" and higher height classes. 16" select dogs will be scored with the 20" Regular dogs. Ribbons will be awarded from 1st to 3rd place in each height group.

Points will be accumulated based on the following system:

Clean Run = 10 points Single Fault Runs = 7 points Two Fault Runs = 5 points Non-E Runs = 3 points Fastest time in class without an E = Bonus 5 points

ELIGIBILITY AND HEIGHT DIVISIONS

Allegria's Award

This prize will be for the peer-nominated dog and handler team that expresses the most joy over the course of the weekend. In their teamwork, their attitude, their expression towars others and their enthusiasm for ISC and the challenges that it brings.

This award will be earned based on nominations from other competitors, the judge, trial committee or volunteers. The individual with the highest number of nominations at the end of the weekend will receive the prize.

NQ Raffle

For any team that earns an NQ in any level run, you will drop a raffle ticket in for a special prize. There will be one winner of this prize.

My First ISC Q

We will have special ribbons for anyone who earns their FIRST ISC Q of the dog's career. This can be earned at any level.



Dogs Eligible to Enter

This trial is open to all dogs 15 months of age or older that are registered with the American Kennel Club or are registerable breeds that have obtained PAL/ILP numbers from the American Kennel Club, except bitches in season, aggressive dogs, blind dogs, or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance. **Mixed breed dogs** listed dogs entered in these events must list the breed name as "Canine Partner" (mixed breed) and not as a breed hybrid and must include their AKC Canine Partners number on the entry form and check the AKC No. Box.

<u>To be eligible to compete to win a spot at the AKC ISC World Team Tryout event the dog</u> must jump at the eligible height in the chart below.

FCI Jump Heights

12" Jump Height: Small Agility for dogs measuring 13 ³/₄ inches and/or less at the withers. 16" Jump Height Medium Agility for dogs measuring 16 7/8 inches at the withers and/or less. 20" Jump Height Intermediate Agility for dogs measuring 18 7/8 inches at the withers and/or less.

24" Jump Height Large Agility for dogs measuring greater than 18 7/8 inches at the withers.

Dogs may be entered in the ISC classes jumping at their regular titling height (Regular or Preferred). Dogs jumping regular titling height that is not compatible with the eligible FCI height will NOT be eligible to earn a spot for the AKC ISC World Team Tryout event.

Jump Height Information

All dogs without height cards will have to be measured by the judge of record, except 24"/24C" dogs. If a VMO or an AKC Representative is available, all dogs without height cards, including 24"/24C" dogs, will need to be measured. When filling out the entry form, there is a new section at the top of the form for exhibitors to designate whether your dog has a valid jump height card or if your dog needs to be measured. Please check the appropriate box so that the Trial Secretary knows whether to include your dogs on the Dogs To Be Measured List. For complete details on the Jump Height Card Process go to <u>www.k-9sports.com</u> and click on the link on the Events page.

SITE INFORMATION AND RULES

The show site is indoors on artificial turf. Please bring your own crate, clean up supplies, & water for your dog. **X-pens are NOT permitted at the show site**. Dogs must be kept on leash when not in the ring. A warm up area will be provided for all exhibitors.

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Trial Committee deems the exhibitor to be in violation of this requirement. \$10 fee for accidents on the turf. Please NO SPIKE SHOES OR HEELS on the turf. Please wear/use clean, athletic footwear to preserve the flooring!

Barking dogs must be kept quiet at all times in consideration of the neighbors.

FIX AND GO ON & FEO INFORMATION

Class Changes Effective January 1, 2020

Entering a Mixture of Regular and Preferred Classes Within the Same Trial Weekend – Multiple Jump Heights Within the Same Trial Day

Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. Any mixture of Regular and Preferred classes is allowed. Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers With Weaves be either both Regular OR both Preferred on the same trial day.

Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24inch Premier STD/JWW on the same trial day.

A separate entry form must be submitted when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

Entering for Exhibition Only (FEO)

FEO allows exhibitors to work with their dogs in a trial environment. FEO is only offered in the Time 2 Beat and FAST classes. Participation in FEO is non-qualifying.

• FEO runs are treated as trial entries. The exhibitor must enter the class(es) (T2B and/or FAST) prior to the closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the entry form; the handler will declare the day of the show.

• Dogs may be entered in any jump height for FEO runs. If entered in an ineligible jump height, the team is committed to FEO for that run and must declare FEO on the start line. Day of show jump height changes are not allowed.

• Dogs may be entered in any level of FAST (Novice, Open, Excellent, Master). If the dog is not eligible for the level entered, the team is committed to FEO for that run and must declare FEO on the start line. Day of show level changes are not allowed.

• The exhibitor must declare FEO in the ring prior to leading out. FEO may be declared earlier (ex. when checking in at the gate board).

• Toys are allowed in the ring. Toys must be non-audible and may not leave the handlers hand. Toys that roll freely may not be used.

Food/treats are not allowed in the ring

• FEO should be utilized for the benefit of the dog and not as a punitive correction. Harsh verbal and /or physical corrections shall not be tolerated. Any

determination of harshness by the judge shall be immediately whistled and the handler will be dismissed from the ring.

• A judge must monitor the entire run. Judges can stop a run at any time (Reminder: This section only needs to be published in the Premium List if the Club is offering FEO.)

Fix and Go On

FNG allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using FNG will result in a non-qualifying score. Fix and Go On is not pre-entered; rather, it occurs during the run

EXHIBITOR INFORMATION

Important Information for Exhibitors

- All owners and handlers are responsible for correctly entering and participating in this trial in accordance with AKC rules. Owners are responsible for errors in entry forms, regardless of who may make such errors.
- All dogs must be on leash at all times except when in the ring or when in the designated agility warm-up area. AKC does not permit pinch/prong collars, electrical or special training collars anywhere on the trial grounds.
- > The safety of dogs is of primary concern. By entering the trial, exhibitors acknowledge that they are familiar with the rules and regulations of the AKC agility program, and that their dogs are familiar with and able to perform all obstacles safely.
- Confirmation of entry and a schedule of judging time will be sent to the address (email will be used when provided on the entry form) on the official AKC entry form after the closing date. If an exhibitor has not received a copy of the schedule at least seven days prior to the show, the trial secretary should be contacted. Returned checks do not constitute a valid entry. If a check is returned, the entry will be deemed invalid, and the issuer will be billed for all trial associated fees, including, but not limited to: AKC fees, judges fees and secretarial fees. Envelopes/transactions containing entries for more than the ten (10) dog maximum shall be treated as an invalid entry.
- Conditional, unsigned, incomplete, illegible, telephone or telegraph entries cannot be accepted. Entries not on official AKC forms or photocopies of AKC forms without the agreement form included are not acceptable.
- 100% of entry fees will be refunded if a <u>written request is received by the trial secretary</u> on or before the trial closing date. After closing, refunds will be given, <u>if notification is</u> received not less than 48 hours prior to the start of the trial, less all fees, for injured or ill handlers, injured or ill dogs. Bitches in season will receive 100% refund. <u>No refunds will</u> be given if request is received after the published commencement of the trial. Verification from a doctor or vet may be required at the club's discretion. No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, acts of God, public emergency, acts of public enemy, or any other cause beyond the control of the organizing committee.
- The Pacific NW Shetland Sheepdog Club, Corral Creek Dog Sports Center, Elissa Looney and Corral Creek Dog Sport Center assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or spectators, or to any of their dogs or property, and further assumes no responsibility for injury to any child not under the control of his or her parents or guardians.
- > The Pacific NW Shetland Sheepdog Club may cancel this event in extreme weather conditions.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the

discretion of the trial committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made. All dogs must be on leash at all times except when in the ring or when in the designated agility warm-up area.

- Please clean up after your dogs while on the show grounds and at the motel site. We want to retain these facilities for future events.
- > Only dogs that are eligible to be shown under the AKC rules shall be allowed within the show precincts.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other person. INSTRUCTIONS

Handlers whose dogs measure into the 8" through 20" regular jump height divisions may opt to enter in a higher or 24-choice **height division** for all **Regular** titling classes, but not in a division lower than their proper height division. Dogs who measure into the 24" regular jump height division may not enter 24-choice. Dogs entered in the **Preferred** classes **must** compete at the required jump height and <u>may not</u> compete in a jump height division <u>higher or lower</u> than their proper height division.

All dogs that have not been officially measured for an **Agility Jump Height Card** may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or *back-to-back trials* only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the **AKC Canine Partners ProgramSM** may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship of the Junior Handler to the Owner?
